Precautionary Statements

4.	FIRST AID MEASURES
Inhalation:	Move to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get immediate medical attention.
Skin contact:	Immediately flush skin with plenty of water (using soap, if available). Remov contaminated clothing and footwear. If symptoms develop and persist, get medical attention. Wash clothing before reuse.

5. FI	RE FIGHTING MEASURES
Extinguishing media:	Water spray (fog), foam, dry chemical or carbon dioxide. Do not use high volume water jet.
Special firefighting procedures:	Wear self-contained breathing apparatus and full protective clothing, such a turn-out gear. Water may be unsuitable as an extinguishing media, but may helpful in keeping adjacent containers cool. Keep personnel upwind of fire.
Unusual fire or explosion hazards:	Vapors may form explosive mixtures with air. Do not handle or store near a open flame, heat or other sources of ignition. 6. ACCIDENTAL RELEASE MEASURES

Clean-up methods:	Remove all sources of ignition. Ventilate area. Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Store in a closed metal container until ready for disposal. Keep upwind of the spilled material and isolate exposure. Refer to Section 8 "Exposure Controls / Personal Protection" prior to clean up.

7. HANDLING AND STORAGE

Handling:

During use and until all vapors are gone: Keep area ventilated - do not smoke; extinguish all flames, pilot lights, and heaters; turn off stoves, electrical tools and appliances, and any other sources of ignition. Make sure containers are properly grounded before use or transfer of material. Prevent contact with eyes, skin and clothing. Do not breathe vapor and mist. Wash thoroughly after handling. Do not taste or swallow. For operations where eye or face contact could occur, provide safety shower and eyewash fountain.

Storage:

For safe storage, store at or below 48.8 $^{\circ}$ C (119.8 $^{\circ}$ F) Keep in a cool, well ventilated area away from heat, sparks and open flame. Keep container tightly closed until ready for use.
