**Acute:** Harmful if inhaled or absorbed through skin. May cause skin and eye burns. May cause respiratory tract irritation. Eye contact may cause severe eye damage, including vision disturbances, corneal damage, and blindness. May cause respiratory sensitization. Overexposure to vapor may cause headache, dizziness, unconsciousness and/or breathing difficulty. Harmful if swallowed. Ingestion is not an expected route of entry in industrial or commercial uses.

Chronic: Prolonged or repeated contact may result in dermatitis. Repeated exposure to high concentrations may cause injury to liver, kidney, and respiratory tract. IARC has designated titanium dioxide (TiO2) as Group 2B – possibly carcinogenic to humans in dust form. However, a number of long term animal studies and human epidemiology studies evaluating TiO2 and workplace exposure show insufficient evidence for carcinogenic effects. EPA, NTP and OSHA do not designate TiO2 as a carcinogen and ACGIH designates TiO2 as A4 - not classifiable as a human carcinogen. Mortaility from other chronic diseases, including other respiratory diseases, was not associated with exposure to TiO2 dust. TiO2 is not present in this product as a dust and no airborne exposure is expected during application.
