4. FIRST AID MEASURES

Inhalation: Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give

artificial respiration. Get medical attention.

Skin contact: Remove contaminated clothing and footwear. Immediately flush skin with

plenty of water (using soap, if available). If skin irritation persists, call a

physician. Wash clothing before reuse.

Eye contact: Rinse immediately with plenty of water, also under the eyelids, for at least 15

minutes. Get immediate medical attention.

Ingestion: Keep individual calm. Do not induce vomiting: contains petroleum distillates

5. FIRE FIGHTING MEASURES

Extinguishing media: Water spray (fog), foam, dry chemical or carbon dioxide. Do not use high

volume water jet.

Special firefighting procedures: Wear self-contained breathing apparatus and full protective clothing, such as

turn-out gear. Water may be unsuitable as an extinguishing media, but may be helpful in keeping adjacent containers cool. Keep personnel upwind of fire.

Unusual fire or explosion hazards:Do not handle or store near an open flame, heat or other sources of ignition.

6. ACCIDENTAL RELEASE MEASURES

Use personal protection recommended in Section 8, isolate the hazard area and deny entry to unnecessary and unprotected personnel.

Environmental precautions: Prevent further leakage or spillage if safe to do so. Do not allow product to

enter sewer or waterways. Advise authorities if product has entered or may enter sewers, water sources or extensive land areas. This product is insoluble

in water and will float on surface.

Clean-up methods: Remove all sources of ignition. Ventilate area. Keep upwind of the spilled

material and isolate exposure. Wear suitable protective clothing, gloves and eye/face protection. Use non-sparking tools for clean-up. Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Store in a partly filled, closed container until disposal.

7. HANDLING AND STORAGE

Handling: During use and until all vapors are gone: Keep area ventilated - do not

smoke; extinguish all flames, pilot lights, and heaters; turn off stoves, electrical tools and appliances, and any other sources of ignition. Avoid contact with eyes, skin and clothing.
