## **Precautionary Statements**

Prevention: Keep away from heat, sparks, open flames, hot surfaces - no smoking. Keep container tightly

### 4. FIRST AID MEASURES

## 5. FIRE FIGHTING MEASURES

If this charge reaches a significantly high level, sparks can form that may ignite vapors of flammable liquids. Vapors may accumulate in low or confined areas, travel considerable distance to source of ignition, and flash back. Vapor accumulation can flash or explode if ignited. In case of fire,

keep containers cool with water spray.
