














#### **Processing suggestions:**

- Properly weigh out the appropriate amounts of resin and hardener.
  - o Mix thoroughly for two minutes being sure to scrape sides and bottom of container.
  - o For best results, de-air the product before pouring into mold.
  - Mold temperature is recommended to be 150 °F for faster de-mold, otherwise longer time in room temperature mold will be required.
